**(To be read or distributed at a regular Post meeting and filed)**

1. The 2023 Department Convention will be held at the Oasis Hotel & Convention Center, Springfield, Missouri, June 8 – June 11, 2023. Reservations for sleeping rooms became available on February 1. Currently, sleeping room reservations are restricted to a three (3) day stay and may be made by calling the hotel direct at 1-888-532-4338 or clicking the link on the attached flyer. Be sure to let them know you are with the VFW. Persons reserving three (3) days and later cancelling one (1) or two (2) will have the entire three (3) days cancelled. We do have an Overflow Hotel if Oasis is full or for anyone wanting to make a reservation for LESS than three (3) days, the hotel is: Holiday Inn & Suites of Springfield and can be reached at 417-865-8600. Attached is a tentative agenda and Banquet Form for the Friday evening Buffet Dinner. Also attached is some information from the Springfield Convention & Visitors Bureau.

2. **Deadline for receipt of Convention Book Ad's is May 12, 2023.** All Post and Districts are encouraged to give recognition to their officers by submitting an Ad for the Convention Book. Add cost are \$100 for Full Page and \$60 for Half Page. The book is being published in ½ size and in house. Please email or Fax Ad request information to Angela @ Department HQ's. 3. The 124th VFW National Convention will be held July 22-27, 2023, at the Phoenix Convention Center in Phoenix, Arizona. Please go to the VFW website at [vfw.org/convention](http://vfw.org/convention) for general convention information including the registration form and links to other convention related information, including a tentative agenda.

4. Attention of Post Commanders is directed to Section 222 of the National Bylaws and the Manual of Procedure, which provides that each Post will pay, in advance, a National Convention registration fee of twenty-five dollars (\$25) which shall entitle the Post to a packet of convention information and materials and one identified registered delegate for the National Convention. Each additional delegate attending the National Convention will pay a ten-dollar (\$10) delegate fee. Posts are encouraged to register their Post delegate(s) online through the Online Membership System (OMS) or by submitting their National Convention Post and Delegate Registration form that is being mailed to all Post. **Post Quartermasters, please send in the \$25.00 registration fee and register at least one (1) delegate as soon as you receive the registration forms. Don't wait until July to send in your delegate fee.**

5. Post and District Commanders should be reviewing the All-State program and know where you need to work to meet the requirements. **The program changes each year, so don't just assume you know the requirements.** District and Post All-State requirements are listed in the District/Post Commander handbook. **To qualify, all requirements, except membership goal, must be met and recorded at Department Headquarters by April 30.**

**Note: Post All-State Membership requirements have changed.** As announced at the Council Meeting on January 28, 2023 you must Meet your July 1, 2022 membership + 1 by June 30, 2023 to qualify for All-State. All Post that meets all requirements by May 1 will receive All-State Honors at the State Convention in June. If membership requirement is met after May 1, 2023, they will be awarded the Post All-State Award at the Fall Council Meeting.

6. **Post Quartermasters**, you will be receiving a letter in early April concerning your Voting Strength and Delegate Dues owed. **Dues must be paid in order to vote at the Convention.** Don't wait to pay your dues at the convention. To help ensure a smooth election process please submit a check to Department Headquarters immediately to avoid last minute chaos and confusion. Checks for Delegate Dues will not be accepted at Convention Registration.

7. Attention is directed to Section 217 of the National Bylaws and Manual of Procedure covering the nomination election, and installation of Post Officers. Post Commanders are reminded that the annual election of Post Officers must be held during the month of April. Nominations of Post Officers shall open in March and remain open until the Post is ready to vote at the April meeting. Post officers shall be installed in their respective offices prior to the convening of the Department Convention. Newly installed officers do not assume their duties until the Department Commander is installed at the State Convention. Post-Election Report Forms are being mailed to Post Quartermasters with instructions that they complete the form online through the Online Membership System (OMS) or they can complete the form and return directly to National Headquarters **immediately following** the election of Post Officers but not later than June 1, 2023.

8.. Pursuant to Section 403 of the National Bylaws and the Manual of Procedure, each District shall hold an annual District Convention for the purpose of electing District officers, such convention to be held not less than ten (10) days nor more than seventy-five (75) days prior to the convening of the Department Convention.

9. Post and Districts are reminded that sections 216, 416 and 516 of the Manual of Procedures states in part: "-----officers, elected and appointed, shall submit proof of eligibility to the Adjutant. ----officers shall not be installed or assume the duties of their office until proof of eligibility has been submitted and properly reviewed. Such proof of eligibility shall be open to and reviewed by the Commander, Adjutant and Quartermaster prior to installation to office."

10. Section 222 of the National Bylaws and the Manual of Procedure provides that delegates and alternates for the District Convention and meetings, Department and National Conventions shall be elected at a regular meeting in April. Posts are entitled to one (1) delegate and one (1) alternate for each thirty (30) members or fraction thereof in good standing in the Post as of March 31.

11. Quarterly Audit Report's for quarter ending March 31, 2023 are due to Department Headquarters no later than April 30, 2023. Audits **MUST** be in by the designated date to qualify for All-State. Postmarks do not count as each Post has 30 days to conduct their audit and mail, fax or email the completed audit report to State Headquarters. **Per sec. 218 (11) b. it's the duty of the Trustee's to conduct the audit and submit the Trustee Report of the Audit to the Department Quartermaster. Any post failing to submit all Quarterly Audit Reports for the year will not be allowed to vote at the upcoming State Convention to be held in June. Audits will not be accepted at Convention Registration.**

12. If your Post has not made a donation to the Veterans Service Officer Program or the Veteran and Military Support Program, please do so ASAP. These are requirements for your Post to earn All-State. **REMEMBER:** VSO checks must be mailed to Department HQs and VMS checks must be mailed to National HQs as stated in your Commander Handbook.

13. The Mid-West Women Veterans Association will be holding their annual women veteran event on April 14-15, 2023. This is a free event and is not limited to only women but is geared toward the unique issues women veterans face. Please see attached flyer for mor information.

14. As of today, March 27, 2023 the Dept. of MO. is at 97.46% in Membership. We are ahead of where we normally are at this time but need to keep working hard. Royce has approximately \$3550 left in the Hospitality Room Fund and to keep the momentum going the Commander has announced a membership incentive. Any Post that is at 100% or greater on January 30, 2023 will have one (1) ticket in a drawing for cash. For every 1% increase in your membership, you will receive an additional entry in the drawing. When your Post reaches 100% you will be entered in the drawing and will receive an additional entry for every 1% increase. Ten (10) entries will be drawn for around \$355 each after the All-State Ceremony at the State Convention. So, keep working on membership. You're Post could win more than once.

15. Mark your calendar for Friday, September 29, 2023. There will be a Charity Golf Tournament benefiting the VFW National Home. The event will be held at the Bear Creek Golf Course in St Charles, MO. Please see attached Flyer for more details and to register.
