All members of the Council, Chairperson, as well as Committees, should make every effort to attend and be prepared to report in accordance with the agenda. - 2. The Big Ten Conference will be October 17-19, 2025, at the Isle Casino Hotel, Bettendorf, IA. Please see attachment for more information.
- 3. This is your annual reminder to get your Liability and Dram Insurance up to date.
  Sec. 709 Control of Units "Any Post owning and/or operating, directly or by reason of a holding company or other entity substantially controlled by the Post or its members, a canteen, clubroom or other facility available to members or guests must maintain general liability insurance, including, if necessary or appropriate, liquor liability insurance. Such insurance must be of a type and amount sufficient to protect the Post and must name, as additional insured's, the Veterans of Foreign Wars of the United States and the Department in which insurance statements.
  - If the Liability and Dram Insurance Blocks on the State Dashboard are **RED** it means we do not have a "Certificate of Insurance' on file for your Post, or it has expired. Please forward a copy, or have your agent send a copy, to Department ASAP. You may mail to 3401 Knipp Dr. Jefferson City, MO. 65109 or email to <a href="mailto:adj@movfw.org">adj@movfw.org</a> or <a href="mailto:hqangela@vfwmo.org">hqangela@vfwmo.org</a>. If your Post no longer has a Canteen, let us know so that we can update the dashboard.
- 4. The National Home trip is scheduled for 24-26 October 2025. If you're going, it's time to get your Route 66 costumes finished. Make sure you post pictures.
- 5. Posts are reminded that **ALL** Officer Changes must be reported to National and Department. - 6. All Posts are required to file a Federal Income Tax return. NO EXCEPTIONS! Posts may obtain forms 990EZ, 990 and/or 990T from any IRS Office, or online at http://www.irs.gov. Posts with a year end of 30 June must file with the IRS prior to 15 November 2023, (most posts have a year end of 30 June). Failure to file will result in the loss of your tax-exempt status.
- 7. All inspection reports should be mailed directly to the Department Inspector, Randle Tolliver, 6689 Highway B, Ellington, MO 63638-9219. If a District Inspector wishes to claim mileage For travel in connection with the inspections, he/she must submit a voucher to the Department Inspector for approval.
- 8. The Voice of Democracy and Patriots Pen Scholarship program needs your support.

  Department needs Posts, Districts, and Auxiliaries to donate to cover these scholarships.
- 9. Reminder to Post Commanders: The National By-Laws and the Missouri All-State Program require the Post Commander to attend, or have a Post Representative attend, all meetings called by the District Commander.
- 10. Anyone requesting a Department Officer to attend a function must submit a **written request** to Department Headquarters at least 30 days prior to the date of the function. An e-mail to the Adjutant at adj@movfw.org is acceptable.
- 11. The attention of Post and District Commanders and Inspecting Officers is directed to section 703 of the National By-Laws - Bonds. Each accountable officer of this organization shall be bonded with an indemnity company as surety in a sum at least equal to the amount of the liquid assets for which he may be accountable. Liquid assets are defined as cash on hand or in the bank and other negotiable instruments readily convertible into cash.
- 12. All Posts should be using the Online Reporting Portal. - 13. All Post are strongly encouraged to log onto the VFW Department of Missouri Webmail. The Post account is post number @movfw.org; i.e.,postxxxx@movfw.org; Please see your predecessor for current password. Please do not change or reset the password. - 14. Article VII sec. 704 of the National By-Laws and Manual of Procedures establishes the requirement for all Posts to establish and maintain a Relief Fund. Expenditures from the relief

fund shall be as prescribed in sections 219 & 704 of the Manual of Procedures. Expenditures authorized include donations to Veteran Service, National Home, and support of the National Guard and their families. Audit Reports received at Dept Headquarters indicate that many Posts may not be meeting this requirement. All Posts are to review their accounting practices and ensure they are meeting this requirement.

- 15. If you have not ordered the 2026 edition of the VFW National Bylaws and Manual of Procedure from the VFW Store, please do so ASAP. You are required to have the latest addition on hand at your Post and District. An online version is acceptable if on the Posts computer.
- 16. **REMINDER**: VMS donations will only be handled through the Dashboard moving forward. An email was sent out June 29, 2023, annotating this change and explaining the NEW donation page. All Posts have to do is click on the VMS donation tab on the Dashboard to donate. The link will point them to OMS. No more checks to National Headquarters.
