Greetings,

We hope you enjoy this issue of the National Council Monthly Update summarizing the pertinent operations at VFW National Headquarters over the last month.

General Counsel

The VFW has been invited to participate in a confidential mediation with Trajector Medical LLC on Feb. 5, 2026. Although the VFW is not a party to the underlying lawsuit (*Warriors and Family Assistance Center v. Trajector*, North Dakota, Florida), Trajector has requested our presence in the mediation in an effort to resolve concerns we have raised — and potentially prevent the VFW from filing a separate legal action.

Trajector is not accredited by the U.S. Department of Veterans Affairs, yet charges veterans significant fees for services directly related to VA disability claims — activities that appear to violate federal statutes and regulations governing who may lawfully assist with such claims. This model not only risks exploiting veterans through improper fees but also creates confusion about legitimate representation options and contributes to improper or unsupported claim filings. We call such companies “Claim Sharks.”

It has been our long-held view that the practices of Trajector (and similar companies) violate federal law and VA regulations, specifically:

- 38 U.S.C. § 5901 and § 5904, which prohibit unaccredited individuals or entities from assisting with VA claims in exchange for payment;
- 38 C.F.R. § 14.636, which strictly limits when and how fees may be charged in the claims process—even for accredited representatives.

This mediation is being conducted under Rule 408, which means that all settlement discussions are confidential and cannot be used in court to prove liability. The VFW’s participation does not waive any of our legal rights, and we remain fully prepared to pursue regulatory or legal action if necessary.

We will use the mediation to seek meaningful reforms that protect veterans, including cessation of unauthorized services, contract and marketing changes, and appropriate relief for affected veterans. We will update the Council following the mediation.

Development

The Development team entered December focused on achieving \$9.2 million. While the month has not yet been officially closed as we continue processing December postmarked mail to ensure donors receive accurate year-end tax receipts, preliminary results are exceptionally strong.

To date, we have recorded nearly 80,000 more responses than last December and total revenue of \$11.1 million, exceeding our monthly goal by \$1.9 million so far. This total includes revenue from VFW’s annual

Year-End Campaign, an online initiative that launched in late November and concluded on Dec. 31. This year's campaign outperformed last year's results by \$114,000, closing at \$1.3 million in total revenue.

These results would not have been possible without the extraordinary collaboration and commitment of Marketing Communications, Innovairre, Merrigan & Company, Further and PRS. All teams contributed countless hours, with PRS working through the holidays to ensure more than 400,000 direct mail responses were processed and deposited efficiently. *Teamwork* truly feels like an understatement.

The following awards are open for nominations:

- **VFW Distinguished Fraternal Award**

To recognize VFW members or citizens who have furthered the aims or ideas of VFW camaraderie. Nominations must show how the nominee displayed efforts to preserve and strengthen a spirit of good friendship and loyalty among VFW members, assisted surviving spouse orphans of deceased members, or assisted vulnerable and at-risk comrades above and beyond what others would or have done.

- **VFW Distinguished Patriotic Award**

To recognize VFW members or citizens in recognition of their local or national patriotic activities. Nominations must show how the nominee displayed efforts that fostered true patriotism by showing and demonstrating a feeling of passion, devotion, and loyalty to America and extended the institutions, traditions, customs, and establishments of American Freedom above and beyond what others would normally do.

- **VFW Distinguished Historical Award**

To recognize VFW members or citizens for contributions to a better understanding of our American way of life, history, and institutions. Nominations must show how the nominee displayed efforts that perpetuated the memory and history of our dead and/or displayed the importance of American history and why that history is important in our institutions above and beyond what others would do.

- **VFW Distinguished Charitable Award**

To recognize VFW members or citizens for service rendered through outstanding charitable endeavors to the country or local efforts. Nominations must show how the nominee displayed a high level of benevolent actions and philanthropic allegiance supporting veterans, civil, political and social

rights that exemplifies the duties and privileges of being an American citizen above and beyond what others would do.

- **VFW Distinguished Educational Award**

To recognize VFW members or citizens for outstanding contribution to the education of the intrinsic values of American freedom and citizenship. Nominations must show how the nominee exemplified through formal, informal or non-formal educational work that teaches the best attributes of patriotism and intrinsic values of knowledge through everyday life above and beyond what others would do.

If you know of a deserving candidate, please submit your nomination by March 6, 2026, via the Programs Dashboard tool. I do understand that not every NCOA member or Department leader has the entry tab on the dashboard. If you do not, please work with your Department HQs, District officers and/or Post officers to submit your nomination.
