Greetings,

We hope you enjoy this issue of the National Council Monthly Update summarizing the pertinent operations at VFW National Headquarters over the last month.

The Council Monthly will resume on Jan. 9, 2026. May your holidays be joyful!

Development

November truly marks the start of the holiday giving season, and it showed in our results. Our revenue objective for the month was \$6,098,513, and we closed at \$7,005,161 — finishing more than \$900,000 ahead of our goal.

Looking ahead, our objective for December is \$9.2 million, with the Year-End Campaign contributing to that overall goal. The campaign kicked off on Nov. 25 and runs through the end of December. It is our largest online effort and typically generates approximately \$1 million in revenue each year.

We also launched our new investment strategy with CTV (connected TV streaming) in November. We recently paused the campaign as initial performance came in below expectations. We are digging into the data now and will resume once several adjustments are made, including refining time slots, shifting the ask from a monthly gift to a possible one-time donation, and reviewing audience targeting to enhance our selects. Because this is the VFW's first initiative using this type of outreach, we are closely monitoring all activity and making thoughtful adjustments to ensure the investment remains within budget. The beauty of CTV compared to direct mail is our ability to dial efforts back, optimize in real time, and relaunch as the data guides us.

If you have participated in the nomination process previously, thank you for your dedication and continued support.

The following awards are open for nominations:

- **VFW Distinguished Fraternal Award**

To recognize VFW members or citizens who have furthered the aims or ideas of VFW camaraderie. Nominations must show how the nominee displayed efforts to preserve and strengthen a spirit of good friendship and loyalty among VFW members, assisted surviving spouse, orphans of deceased members, or assisted vulnerable and at-risk comrades above and beyond what others would or have done.

- **VFW Distinguished Patriotic Award**

To recognize VFW members or citizens in recognition of their local or national patriotic activities. Nominations must show how the nominee displayed efforts that fostered true patriotism by showing and demonstrating a feeling of passion, devotion, and loyalty to America and extended the institutions, traditions, customs, and establishments of American Freedom above and beyond what others would normally do.

- **VFW Distinguished Historical Award**

To recognize VFW members or citizens for contributions to a better understanding of our American way of life, history, and institutions. Nominations must show how the nominee displayed efforts that perpetuated the memory and history of our dead and/or displayed the importance of American history and why that history is important in our institutions above and beyond what others would do.

- **VFW Distinguished Citizenship Award**

To recognize VFW members or citizens for service rendered through outstanding charitable endeavors to the country or local efforts. Nominations must show how the nominee displayed a high level of benevolent actions and philanthropic allegiance supporting veterans, civil,

political and social rights that exemplifies the duties and privileges of being an American citizen above and beyond what others would do.

- **VFW Distinguished Educational Award**

To recognize VFW members or citizens for outstanding contribution to the education of the intrinsic values of American freedom and citizenship. Nominations must show how the nominee exemplified through formal, informal or non-formal educational work that teaches the best attributes of patriotism and intrinsic values of knowledge through everyday life above and beyond what others would do.

If you know of a deserving candidate, please submit your nomination by March 6, 2026, via the Programs Dashboard tool. I do understand that not every NCOA member or Department leader has the entry tab on the dashboard. If you do not, please work with your Department HQs, District officers and/or Post officers to submit your nomination.

Mail received at National Headquarters prior to Dec. 30, 2025, will be processed and counted in the December total. The mail received after that date, regardless of the postmark date, will not be counted in the December total. We suggest you have your Posts mail in their membership as early as possible or take advantage of the Online Membership System tools.
- The OMS system will be back online for the submittal of transactions by 4:00 p.m. CST, Jan. 1, 2026; however, membership transactions that are processed will not be posted to Memstats until all pertinent data is secured and verified. This should occur on (or before) Jan. 6, 2026.

National Legislative Service

- **VFW Submits Testimony for House Subcommittee Hearing:** VFW National Veterans Service Director Michael Figlioli submitted a statement for the record to the House Veterans' Affairs Subcommittee on Disability Assistance and Memorial Affairs for an oversight hearing on VA's Medical Disability Examination Office. He explained that although the VFW has repeatedly identified and offered solutions for persistent shortcomings in VA's examination and contracting processes, the system remains overly complex, burdensome and difficult for many veterans to navigate, especially those without accredited representation. Figlioli urged Congress and VA to modernize and stabilize the examination infrastructure and outlined recommendations for improvement in five key areas. - **VFW Speaks Out on Hemp Ban:** In an open letter to the leaders of the House and Senate, VFW National Commander Carol Whitmore and Adjutant General Dan West urged bipartisan support for responsible, scientifically grounded research into hemp cannabinoid-based alternative treatments for veterans suffering from conditions like post-traumatic stress disorder, anxiety and chronic pain. The VFW has a resolution supporting research into alternative medical treatments for veterans whose symptoms have gone unresolved by traditional medications, which have left some veterans physically, mentally and emotionally worse off. - **VFW Joins House Committee Roundtable on State of VA Benefits:** VFW Washington Office Executive Director Ryan Gallucci participated in a roundtable led by House Committee on Veterans' Affairs Ranking Member Mark Takano and attended by House Minority Leader Hakeem Jeffries. The roundtable focused on the current and future state of veterans' benefits. Gallucci stressed the VFW's message to "Honor the Contract" between service members and the federal government. Veterans were willing to risk their lives in defense of our nation, and in return the government must uphold its promise to care for those injured or made ill by that service. Amid growing scrutiny of VA's disability compensation system, he emphasized that protecting its integrity starts with honoring the fundamental contract. [Watch the full roundtable.](#)
- **VFW Testifies at Senate Committee Hearing:** VFW Washington Office Executive Director Ryan Gallucci testified before the Senate Committee on Veterans' Affairs during an oversight hearing on the VA disability system prompted by recent news reports alleging fraudulent practices within the compensation claims process. Gallucci emphasized the VFW's challenge to "Honor the Contract" between service members and the government. He asserted, "Our veterans didn't ask what was in the air they breathed or the water they drank. And unlike many other public servants, they couldn't just walk away if they didn't want to do it anymore. They served in accordance with the contract they signed. Many now live with illnesses that steal their sleep, their breath and their ability to work. Suggesting that they embellish their suffering for money is insulting." Accordingly, the federal government must fulfill its responsibility to care for those injured or sickened in service.
