Another successful month of fundraising is officially in the books! Our November goal was set at \$6.4 million, and we closed out the month at \$7.3 million. This achievement is a testament to the dedication and generosity of VFW's supporters.

Looking ahead, the VFW's Year-End Campaign is now underway and will run through Dec. 31. This year's goal is \$1.2 million, slightly higher than last year's outcome of just over \$1 million. Your help in sharing this campaign on your social media channels would be invaluable. Every share will increase awareness and bring us closer to achieving our goal. Additionally, we ventured into new territory with a texting campaign over Veterans Day. The initial results were very encouraging, as the campaign not only generated a net positive return but also appended 57,000 valid phone numbers to our donor file. This effort provides valuable data for our Planned Giving and Major Gifts Officers. With the texts we received back, we were able to also identify additional veterans in our non-member donor file. The promising outcome has paved the way for another test this month during our Year-End Campaign.

The internal RFP Review Committee is meticulously evaluating the finalists' presentations with the goal of recommending the agency best suited to ensure the continued growth and success of this vital revenue stream for the organization. A formal recommendation will be presented to the Adjutant General and Quartermaster General in the coming week.

The mail received after that date, regardless of the postmark date, will not be counted in the December total. We suggest you have your Posts mail in their membership as early as possible or take advantage of the Online Membership System tools.
- The OMS system will be back online for the submittal of transactions by 4:00 p.m. CST, Jan. 1, 2025; however, membership transactions that are processed will not be posted to Memstats until all pertinent data is secured and verified. This should occur on (or before) Jan. 6, 2025.

- Proxy configuration is being done so DC staff can remote in directly to the DC office which should speed up connectivity.
- The Command Post system is progressing. They are breaking down different screens and reviewing database processes. We have a new logo for Command Post.
- There are 65 NVS laptops being replaced due to the end of life (EOL) cycle.
- Reconfiguring Mimecast is being done to block more spam and not legitimate emails.
- Both the DC and KC main servers are coming to the end of life (EOL), and IT is reviewing proposals for replacements.

# National Legislative Service

- VFW National Legislative Service Associate Director Nancy Springer provided a statement for the record for a House Veterans' Affairs Subcommittee on Disability Assistance and Memorial Affairs' hearing on a review of funeral operations at VA national cemeteries. <u>Read the testimony</u> or <u>watch the hearing</u>, which begins at the 19:20 mark.
- VFW National Legislative Service Deputy Director Kristina Keenan spoke at the final event of the Servicewomen and Women Veterans Caucus of the 118th Congress, led by Reps. Chrissy Houlahan, Jen Kiggans, Derrick Van Orden, and Brad Wenstrup, all of whom are veterans. Keenan cited VFW-supported legislation <u>H.R.3933</u>, TAP Promotion Act, and <u>H.R.4157</u>, Not Just a Number Act that would improve the transition process and gather data regarding women veterans and suicide risks.
- The Senator Elizabeth Dole 21st Century Veterans Healthcare and Benefits Improvement Act, <u>H.R.</u> <u>8371</u>, passed in the House with a bipartisan vote of 389-9. See how your members of Congress <u>voted</u>.
